## **Monographs-in-Progress**

I am working concurrently on three book-length projects. These concern: (1) a cultural historical critique of the category "folk" as applied to arts and other cultural artifacts (and, disturbingly, also to the people who produce them). My project maps "folk's" uses in 20th- and 21st-century efforts to naturalize problematic framings of race, religion, class, and gender; (2) a study of the (indigenous Hawaiian religious) foundations of American art criticism as shaped by James Jackson Jarvis's early adulthood years among Protestant missionaries in Hawai'i and his (mis)appropriations of Hawaiian practice (Jarvis is often named as the "first" American art critic; among scholars his story generally begins well after his travels in the islands). This project extends into the present, aiming to understand Hawaiian activist reclamations of traditional practices of religious and political aesthetics (including some of those "relocated" by Jarvis); (3) a companion volume to *Religion in Plain View* that engages in detail approximately five different American religious communities, working from the "trees" rather than the "forest" (*Religion in Plain View* intentionally focused attention on the latter).

## ADVISING AND MENTORING

I take advising and mentoring very seriously; it has always been for me a key part of my academic labor and commitment. Advising and mentoring happen here on this campus, of course, but also with students and junior faculty at other institutions, in the USA and abroad. I have shaped the national and international collaborative projects that I direct in order to make dedicated space for mentoring the next generations of scholars and educated citizens. I have worked to structure grant-funded projects that make ample allowance for mentoring graduate students and junior faculty, as full collaborators and scholars in their own right.

Following convention at the University of Maryland, where I began my tenure-track career in 1991, I have not felt it appropriate to name the students I advise and mentor, nor to list their master's theses and doctoral dissertations on my CV. This has seemed to me, in the past, to be claiming responsibility for student successes that belong to the student alone. I have come to see a different wisdom in this accounting and to consider whather it is possible to rechart /recoup this history moving forward. My current CV, however, does not include such ennumerations.

## GRADUATE ADVISING

At Yale, in 2022, I served in a range of capacities of formal advisement for five doctoral students. I am also principal advisor to ten master's students in the Institute of Sacred Music and Yale Divinity School. Each year, I supervise at least one, and often two or three, ISM/YDS master's thesis projects. I also frequently (at least once per semester, and often twice) advise/teach a readings course or independent study at the master's level, often these courses have multiple students. In addition, I continue to write letters for and mentor some among my University Maryland former graduate students and I serve on external dissertation committees. Among these, I have participated as an external reader, over the course of my career, on dissertation committees at such institutions as the University of California, Berkeley, University of Chicago, Stanford University, the University of North Carolina at Chapel Hill, University of Texas at Austin, SUNY Stony Brook, the University of Virginia, and the George Washington University.

## UNDERGRADUATE ADVISING

At Yale University, to date, and because of the shape of my appointment, I work principally with graduate students. I occasionally serve as a reader/advisor for senior essay projects, as I did in 2022. I welcome qualified undergraduates into my graduate-level courses (my syllabi and advance course information always include this invitation). At the University of Maryland, I served as departmental Director of Undergraduate Studies in 1999. Periodically I provided program for the Undergraduate Art History Association.
