(1942 - 2019)



Co-founder of the Yale-Edinburgh Group on the History of the Missionary Movement and World Christianity, Professor Sanneh came to the Yale Divinity School in 1989 as the D. Willis James Professor of Missions and World Christianity. He also held appointments as Professor of History and Professor of International and Area Studies at Yale. He was the author of more than a dozen books on Islam and Christianity and over two hundred articles in scholarly journals. Professor Sanneh was the recipient of many major awards and honors, including an honorary doctorate from the University of Edinburgh in 2002. We mourn his passing and celebrate all his contributions to the Yale-Edinburgh Group and our fields of study.

This is the twenty-ninth meeting of the Yale-Edinburgh Group on the History of the Missionary Movement and World Christianity. The conferences are sponsored by the Centre for the Study of World Christianity at the University of Edinburgh, the Overseas Ministries Study Center, and Yale Divinity School.
